Traffic State Estimation Using Floating Car Data

Abstract

There is an increasing availability of floating car data both historic, in the form of trajectory datasets and real-time, in the form of continuous data streams. This paves the way for several advanced traffic management services such as current traffic state estimation, congestion and incident detection and prediction of the short-term evolution of traffic flow. In this paper, we present an analysis of using probe vehicles for reconstructing traffic state. We employ detailed agent-based microscopic simulations of a real world expressway to estimate the state from floating car data. The probe penetration required for accurate traffic state estimation is also determined.

Keywords: Traffic state estimation, Simulation and modelling of transportation systems, Agent-based simulations

1 Introduction

Floating cars refer to moving probe vehicles which act as traffic sensors by providing information regarding their position α (in terms of coordinates) and speed v_{α} at regular intervals. The locations provided via GPS receivers can be map-matched to roads on a map. In turn this map-matched data can be used to reconstruct traffic state constituting the macroscopic quantities density ρ , flow Q and local speed \bar{V} . Identifying regions of uniform flow and density will help determine traffic patterns of interest such as jams, stop-and-go waves and changes in traffic flow especially in the face of events such as accidents. In this paper we develop a methodology for aggregating floating car data (FCD) for accurate traffic state reconstruction. The minimum probe penetration required for determining the traffic state is also determined by simulating different traffic flow regimes on a real world expressway.

Reconstruction of traffic state in real-time using FCD (in the form of data streams) will also enable initializing data driven traffic simulations for short term predictions of flow. This can lead to a *symbiotic traffic simulation platform* [2] where the simulation system benefits from

the real time data provided by the physical system (the road network) which in turn benefits through mechanisms such as dynamic ramp metering and congestion aware routing [15].

Reconstructing traffic state from probe vehicles has been previously discussed in papers such as [10, 8] and [6]. In this work we attempt to determine traffic density and flow traditionally computed through stationary devices such as loop detectors [3] and video cameras [4], using FCD. Towards this end the contributions of this paper are -

- 1. A methodology for obtaining aggregated macroscopic (speed, density and flow) quantities from the microscopic FCD consisting of (α, v_{α}) .
- 2. An estimation of the minimum percentage of probe vehicles required for the macroscopic traffic state reconstruction under different traffic flow regimes.

2 Existing Work

Using FCD as a means for estimating travel times and traffic state has received much attention over the years. Papers such as [6] and [12] compute the average travel time on roads from the average speed of the probes on that road. Techniques such as artificial neural networks are used for short term predictions by using weighted aggregates of the past patterns [6]. While using the trajectories of probe vehicles to detect events such as congestion and accidents has been discussed in [1].

The percentage of probe vehicles required for reliable travel-time estimation has been discussed in papers such as [5] and [8]. The work in [10] is concerned with estimating the percentage of probe vehicles for accurately determining the travel-time across the road-network links. Based on numerical simulations (details of the simulation model are not provided), the authors conclude that 1.5% penetration of probe vehicles are needed for accurate travel time estimation.

While the authors of [8] estimate the probe penetration (to be around 2%) and the sampling period to maximize traffic information by determining traffic time and space correlations. Two spots are correlated in space if the correlation of average speeds in both the spots exceeds a threshold. Thus, the traffic condition in a spot without measurements can be estimated if the condition in a correlated spot is known, thus influencing probe penetration. Likewise the correlation time measures the period over which the traffic conditions remain correlated in a spot hence influencing the sampling period. The traffic time and space correlations were measured using microscopic simulations. The details of the simulation parameters are not provided.

Similarly [5] defines confidence intervals for accuracy in terms of average speed and travel times across the links apart from spatial coverage as a function of probe penetration. The authors conclude that 3% to 5% probe penetration is sufficient for confidence levels of 90% and above.

To the best of our knowledge, there have been no attempts made at estimating traffic flow and density from FCD. This is generally due to the papers focusing mainly upon estimating travels times from FCD which is in contrast to the requirements of a symbiotic traffic simulation platform requiring knowledge of the current state in terms of ρ , Q and \bar{V} . Further, most employ macroscopic models which do not take into account the heterogeneous driving characteristics and vehicle lengths and instabilities arising due to lane changes. This results in optimistic conclusions on the minimum probe penetration required. In this work we show that, provided sufficient probe penetration, the traffic state constituting average speed and more importantly density (and flow) can be reliably measured.

3 Methodology

For determining the methodology for spatial aggregation of FCD and the minimum probe penetration for accurate traffic state estimation, we employ agent-based microscopic traffic simulations. Microscopic simulations of real world expressway were employed owing to lack of real-world floating car data.

Once the (α, v_{α}) pairs for the road stretch simulated is obtained, an algorithm for partitioning the FCD is required for determining the aggregated values of traffic density and in turn, the flow. In order to do this, the partitioned regions must be microscopically large enough to contain sufficient samples of (α, v_{α}) pairs and be macroscopically small to determine traffic patterns of interest such as congestion and variations in flow [14].

The first method for spatial aggregation evaluated, naively divides the expressway into uniform chunks of size 1.0 km each resulting in 13 segments in total. The second method evaluated makes use of the topology of the expressway and divides it into segments between on/off ramp pairs. The final approach divides the expressway into M segments such that the variance of the speeds within all segments are minimized. Formally, the goal is to find

sections
$$S_1, \ldots, S_J$$
 that minimize the total variance of the speeds given by $\sum_{j=1}^J \sum_{i \in S_j} (v_i - \bar{V}_{S_J})$.

Where \bar{V}_{S_J} represents the average speed in section S_j . This computationally hard optimization problem (due to the infinite number of ways in which the expressway can be divided into J sections) is solved using a top down greedy approach known as recursive binary splitting [9]. The constructed binary tree is split until a minimum of 10 samples are present in each leaf node. The tree so grown is pruned (to prevent over-fitting) using cost-complexity pruning [9].

The efficacy for spatial aggregation is determined based on the best model fit that can be obtained for ρ as a function of \bar{V} . To quantify the reliability of the model, we make use of the R^2 Statistic. This metric used henceforth in this paper is a measure of model fit in the form of a proportion of variance explained by the model [9]. It takes a value between 0.0 and 1.0 and a value close to 1.0 indicates that a large proportion of the variability in the density is explained by the predictor, which in this case is the speed \bar{V} .

Once the relationship between ρ and \bar{V} is established, we look at quantifying the accuracy of traffic state estimation as a function of probe vehicle penetration for different traffic conditions. This helps to determine the minimum probe penetration required.

4 Experiments

Microscopic models describe traffic from the perspective of individual driver-vehicle units (DVUs). These high-fidelity simulations should ideally capture heterogeneities in traffic in terms of different vehicle classes (e.g. cars, trucks) and driver behaviors (e.g. intelligent, aggressive). Further, the microscopic simulations employed for this study also model stochastic lane changes thus helping to reconstruct the spatiotemporal state of traffic with far greater accuracy in comparison to macroscopic models. The movement of driver-vehicle units are characterized by acceleration models for longitudinal motion and lane change models for lateral movement along the road. In this section, we provide the details of our microscopic simulation and of the real world expressway in Singapore we simulate.

4.1 Traffic Simulation

The traffic simulation we have employed, is based on the *SEMSim* platform [16]. SEMSim is a high fidelity agent-based microscopic simulation. It uses the *Intelligent Driver Model* (IDM) [13] and MOBIL [11] as the acceleration and lane change models respectively.

The IDM is an accident free model which ensures that a vehicle attains the desired velocity at free flow and maintains the safe bumper to bumper distance to the leading vehicle. It also ensures that the acceleration is an increasing function of the speed and distance to the leading vehicle and a decreasing function of its speed. MOBIL, the lane change model ensures that the resultant accelerations and decelerations for a vehicle and its followers in the old and new lanes does not exceed a safe threshold. A lane change is done only if a vehicle gains speed without violating the safety and inconvenience (to the old and new followers) criteria.

The simulation takes as input a road network detailing the lanes constituting the roads to be simulated. Road segments that don't have a preceding road segment are considered sources and those without a subsequent segment are sinks. The traffic thus flows from the sources to the sinks. Vehicles are created at each source as a Poisson process based on the equation $nextTime_s = \frac{-lnU}{\lambda_s}$. The parameter $nextTime_s$ represents the time of arrival of a vehicle on a source road s. The mean inter-arrival time for s (in seconds) is given by λ_s . The parameter U is a random number between 0 and 1. The mean inter-arrival times λ_s of vehicles on a source link s controls the average vehicle density on all roads simulated. It represents the expected value of the number of agents entering the simulation via a source road. The route taken by each DVU is determined based on static turn ratios specified at each intersection. Other inputs to the simulation include time, number of agents and probability distribution of other model parameters.

4.2 The Simulated Environment




Figure 1: Simulated section of P.I.E (Singapore) and location of all on/off ramps.

For the experiments in this paper, we simulated a 13 km stretch of P.I.E (Pan Island Expressway) in central Singapore (Figure 1) with all on and off ramps. The on ramps and the first P.I.E link are sources, while all off ramps and the last link on P.I.E are sinks. Refer to the

Table 1 for the location of all on/off ramps (or *static bottlenecks*) starting from the beginning of the first road-segment on P.I.E. The average distance between two bottlenecks is around 565 m along this stretch of P.I.E. The turn ratios for all off-ramps is kept constant at 0.25. This implies that 25% of all vehicles exit at a given off ramp while the remaining 75% of the vehicles continue to travel on the main expressway. The number of lanes in the simulated stretch of the expressway varies between 3 and 6.

4.3 Simulation Parameters

The microscopic traffic simulation of P.I.E was initialized with the parameters listed in Table 2. Parameters such as a, b and l_i are modeled as distributions to take into account heterogeneous driving behaviors and vehicle classes respectively. In order to obtain a ballpark figure for congestion in terms of vehicle density, we make use of the simplest of the Lighthill Whitham Richards (LWR) models using a triangular fundamental diagram [14]. The critical density for congested traffic ρ_c , according to the LWR model is given by $\frac{I}{V_0 \times T + l_{eff}}$. Here l_{eff} represents the minimum distance headway which is the sum of average vehicle length and minimum gap s_0 . Vehicle density exceeding ρ_c generally implies a congested traffic flow regime.

Based on the parameters listed in Table 2, ρ_c works out to around 31 vehicles/km/lane. Thus we consider traffic greater than 93 vehicles/km, (assuming the minimum of three lanes) as congested. In fact, each traffic scenario (discussed later) is also characterized based on the average vehicle density during the simulation period of 2 hours. It is to be noted that the LWR based triangular fundamental diagram overestimates the critical density since it ignores vehicular interactions such as lane changes and assumes homogeneous traffic, but nevertheless serves as a rough estimate for congestion.

4.4 Simulation Scenarios

The traffic density (ρ) in number of vehicles/km across the expressway is controlled by varying the average inter-arrival rates at all sources along P.I.E. The density of the entire expressway is computed at the end of the two hour simulation by counting the number of distinct agents per kilometer of the road. To simulate heavy congestion along P.I.E the parameter λ_s for all on-ramps was set to a uniform random number between 2.0 sec and 2.5 sec (representing a flow of 1800-1440 vehicles/hour) while λ_s for the first and only source link of P.I.E was set to 1.0 sec (3600 vehicles per hour). The sampling period of all probe vehicles unless stated otherwise is

1 second, i.e. the probe vehicles provide information regarding their speed and position every second.




Figure 2: Microscopic simulation of heavily congested traffic at 110 veh/km, speed in (m/s)

Figure 2 shows the spatiotemporal state of P.I.E in a heavily congested state. The heat map represents the speed profiles of all the agents averaged over space and time intervals of 50 meters and 1 minute. Traffic build up in the form of blue bands are clearly visible in the regions where on and off ramps intersect along the main P.I.E expressway. The average traffic density along the main expressway (ignoring the on/off ramps) during the time period of simulation was around 110 vehicles/km which is greater than the critical density ρ_c for P.I.E.




Figure 3: Microscopic simulation of partial and minimal congestion on P.I.E, speed in (m/s)

Figures 3a and 3b shows the spatiotemporal state of P.I.E during partial congestion and non-peak traffic at average densities of 78 and 65 vehicles/km respectively. These scenarios as discussed in Section 5.2 will be used to determine the minimum probe penetration required for accurate traffic state estimation using FCD. Note that three scenarios simulated in Figures 2 through 3b assume a 100% probe penetration.

5 Results

In this section, we reconstruct the macroscopic traffic state of P.I.E by aggregating the speed profiles of probe vehicles based on the three different spatial aggregation techniques discussed in Section 3. We also determine the minimum probe penetration required for accurate traffic state estimation.

5.1 Spatial Aggregation of FCD




Figure 4: Density vs Speed for different spatial partitioning mechanisms

Figure 4a shows the plot of ρ (in vehicles/km) as function of \bar{V} when the P.I.E is divided into equal sized segments of length 1.0km. The method does not take into account the topography of P.I.E nor does it try to identify regions with a homogeneous distribution of speeds. While Figure 4b shows the ρ vs \bar{V} graph by aggregating FCD based on the 25 road segments comprising the P.I.E stretch simulated. Both the figures clearly establish an exponential relationship (based on the linear regression fit) between \bar{V} and ρ despite significant bias.

The recursive binary partitioning approach (Section 3), divides P.I.E into homogeneous partitions (numbering 12 in this case) based on the speed profiles of probe vehicles. Figure 4c further establishes the exponential relationship between ρ and \bar{V} with much lesser noise in comparison to splitting using the two aforementioned approaches. The exponential relationship between ρ and \bar{V} in agreement with the *Underwoods's exponential model* [7]. We thus fit a linear model as shown in Equation 1 for estimating traffic density from average speed. The coefficients β_0 and β_1 are the least squares coefficient estimates for linear regression.

$$\rho = \beta_0 + \beta_1 \times log(\bar{V}) \tag{1}$$

In the next section we show that the recursive binary splitting approach is the better method for spatial aggregation of the (α, v_{α}) pairs considering lesser levels of probe penetration.

5.2 Probe Penetration for Effective Density Estimation

In this section, we determine the accuracy of the exponential speed density model (Equation 1) at different levels of probe penetration. This helps determine the minimum probe penetration required for the three different traffic flow regimes discussed in Section 4.4. We expect the

accuracy of the exponential speed-density model (Equation 1) to decrease as the probe penetration decreases. The dip in accuracy can be attributed to significant variation in the speed of vehicles in different lanes owing to entry and exit of vehicles at on/off ramps, heterogeneous driver vehicle characteristics and stochastic lane changes. The aforementioned instabilities in traffic flow are modeled in the microscopic simulations as explained in Section 4.




Figure 5: R^2 Statistic vs probe penetration for heavily congested traffic

Figure 5 plots the R^2 Statistic of the exponential model (Equation 1) as a function of probe penetration for the three different aggregation methodologies discussed in the previous section. The results show the averaged R^2 Statistic for five different two minute sub intervals of the

two hour simulation of the heavily congested traffic in Figure 2. The R^2 statistic expectedly shows a downward trend as probe penetration decreases for all three aggregation methodologies. Figure 5 clearly shows binary splitting to be a superior approach for spatial aggregation enabling a reasonable estimate of ρ even at a probe penetration as low as 5%.




Figure 6: R^2 Statistic vs probe penetration for partial and minimal congestion

Figure 6 plots the R^2 Statistic (of the exponential model fit) for recursive binary partitioning approach as a function of probe penetration for the traffic conditions shown in Figures 3a and 3b. It is interesting to note that the accuracy of the model (Equation 1) decreases as the level of congestion decreases. This can be explained by the fact that vehicles generally travel at uniform speeds during heavy congestion (refer Figure 2) and during free flow resulting in minimum variance of speeds across lanes. While partially congested traffic regimes in Figures 3a and 3b generally tend to have a far greater variance in speed due to vehicles traveling at varying speeds in different lanes.

5.3 Flow estimation and temporal aggregation of FCD




Figure 7: Traffic flow and temporal resolution estimation for recursive binary splitting

Using the relation $Q = \rho \times \bar{V}$ the flow-density fundamental diagram is obtained as shown in Figure 7a at probe penetration of 10%. The average speed \bar{V} and the density ρ were aggregated using the recursive binary split for a two minute subinterval. The critical density for congestion (ρ_c) is around 100 vehicles/km for P.I.E.

Figure 7b provides the average R^2 Statistic as a function of probe penetration and temporal aggregation intervals. Five two minute sub intervals of the scenario shown in Figure 2 were

used for computing the aggregate R^2 Statistic. Clearly the accuracy of the density prediction decreases as the temporal aggregation interval increases. The graph indicates that acceptable accuracy of density estimates from FCD (when used in conjunction with binary splitting) is obtained at resolutions of around 15 to 20 seconds. This result thereby estimates the sampling period of probe vehicles required for traffic sate estimation. Increase of the probe sampling period to around 15 seconds significantly reduces the computational resources required for real-time map matching and traffic state reconstruction.

6 Conclusions and Future Work

In this work we have established that reliably estimating traffic state and more specifically density (and thereby flow) on an expressway can be achieved with a minimum of 5% to 10% probe vehicles depending upon the prevailing traffic conditions. Microscopic traffic simulations reveal that recursive binary partitioning can be used to subdivide a stretch of road to identify homogeneous regions of Q, ρ and \bar{V} .

In the future, we would like to investigate if the results obtained on a relatively homogeneous expressway can be replicated on signalized urban street networks. Future work would also involve optimizing the minimum variance partitioning of the road network to automatically detect onset of congestion and anomalous events such as accidents based on statistical learning methods. Accurate estimation of speed, density and flows along important roads can help initialize data driven simulations for short term predictions of the evolution of traffic flows. Predictive simulations will play a major role in enhancing the capabilities of dynamic control strategies such as ramp metering and routing for traffic flow optimization.
